PANDEMIC DIARIES PROJECT

OVERVIEW:

I believe the best way to learn sociology is to do sociology. As such, this semester we will engage in a Pandemic Diaries Project. This will involve the entire class in research aimed at understanding how the pandemic has affected the generation of young adults born in 1995 or later. Most of the students in this class are part of this generation, so you will be writing about your own experiences as well as learning about those of your peers. Specifically, you will receive training in the ethical conduct of research, collect and analyze data, and write a final essay for this project.* All students should complete and submit **3 out of the 5** following homework assignments:

- Homework 1 - Your Pandemic Story Through a Sociological Lens (10 pts)**
- Homework 2 - Institutional Review Board (IRB) CITI Training for Research (10 pts)**
- Homework 3 - Pandemic Diaries Interview Sample (10 pts)**
- Homework 4 - Pandemic Diaries Interview Preparation and Interview Guide Questions (10 pts)**
- Homework 5 - CONVERGE Broader Ethical Considerations for Hazards and Disaster Researchers Training Module (10 pts)**

EVALUATION:

You have the opportunity to earn up to 30 points if you submit 3 out of 5 possible homework assignments. The 3 highest scores of the 5 possible homework assignments will be counted toward your final course grade. Your 2 lowest scores will be dropped. Each individual homework assignment is due via Canvas by 11:00 p.m. on the Thursday indicated in the course schedule in this syllabus and on Canvas. Up to 10 points will be awarded for each homework that is completed and submitted by the deadline. Please note that each assignment has its own evaluation criteria included with the instructions.

ASSIGNMENT DETAILS:

» Homework 2 - Institutional Review Board (IRB) CITI Training for Research (10 pts)

- **Overview:** This second homework assignment asks you to complete an online training required of all researchers at the University of Colorado Boulder who are engaged in human subjects research. After you have completed the training, you will need to download your certificate so you can upload it to Canvas. Please note that it may take you between 1 to 5 hours to complete this training, depending on how quickly you read and process information.
- **Submission Requirements:** This homework assignment is due by no later than **11:00 p.m. on Thursday, September 8, 2022 via Canvas > Assignments > Homework 2 folder.**
 - * The IRB certificate must be submitted as a Microsoft Word (.doc or .docx) or Adobe PDF (.pdf) file.
 - * Note that .pages files will not be accepted as they are not accessible on non-Apple devices.
 - * Emailed assignments will not be accepted under any circumstance.
 - * Leave yourself ample time to ensure that you can upload your homework to Canvas before the deadline and in the proper format.
- **Evaluation:** Students who complete the required training and upload their certificate of completion on time will receive 10 points for this homework assignment.



- Click on **University of Colorado at Boulder Courses**.







* **Adding a Course:**

1. Click **University of Colorado at Boulder Courses**. Then click **Add a Course**.



2. Select **Human Research for the IRB** then click **Next**.
3. Select **Social Behavioral Research Investigators and Key Personnel** then click **Next**. – The course will appear under University of Colorado at Boulder Courses on the Main Menu.



□ **Step Three - Complete the Course**

- On the Main Menu, all of your affiliated institutions are listed.
- From the dropdown under **University of Colorado at Boulder Courses**, complete the modules for the **Social Behavioral Research Investigators and Key Personnel** course.
- To complete a course, click the course title in the Course column from the table in the dropdown. – Modules may vary based on institutional requirements.
- When the course is completed, you will receive a verification email from CITI.

» **Homework 5 - CONVERGE Broader Ethical Considerations for Hazards and Disaster Researchers Training Module (10 pts)**

- **Overview:** This homework assignment requires you to complete an online training module focused on the broader ethical considerations of hazards and disaster research. After you have completed the training, you will need to download your certificate so you can upload it to Canvas. Please follow the detailed steps outlined below. It will likely take you 1 to 2 hours to finish the training module and 10 question quiz, depending on how quickly you read and process information. Please plan accordingly so that you can submit on time.
- **Submission Requirements:** This homework assignment is due by no later than **11:00 p.m. on Thursday, October 6, 2022 via Canvas > Assignments > Homework 5 folder.**
 - * The CONVERGE Training Module certificate must be submitted as a Microsoft Word (.doc or .docx) or Adobe PDF (.pdf) file.
