Virtual Forum – Purpose

After a disaster, universities are often eager to assist impacted areas and people through providing aid and support, sponsoring service-learning trips, or conducting research aimed at collecting perishable data. When **well-coordinated and rooted** in local needs, these post-disaster interventions can positively inform response and recovery efforts. Sometimes, however, when these efforts are ad hoc and ephemeral, they can negatively affect communities already damaged by catastrophe.

This forum will feature researchers who responded to the earthquakes that have recently shaken Puerto Rico. The presenters will reflect on the **ethical and practical implications of their interventions**. At the end of the discussion, they will offer **lessons learned and recommendations** for how to balance academic demands and expectations with the survival needs of communities that have experienced collective and cumulative trauma.










SO many "new" issues with disaster lawyering work


