@Ramesh Singh: The official cause of the fire is still under investigation by the county and the FBI, but it seems fairly clear that it started on private land.

The issue is that the entire event was based on warming atmospherics based on climate change, period. The warm air inversion that increased the intensity of the chinook winds coupled with the unseasonal abnormally dry early winter in the Front Range. Tragic.
